Reports were presented and viewed by the Board.

Diane VanSlyke, Town Historian, reported that the Historical Society Building, with a 165-person capacity, has been rented out several times during the last month. Diane books the rentals. Darren Ball submitted an end of the year report. He said there were 342 calls for 2022; 189 were transports.
