Historian Diane Van Slyke gave her monthly report. Supervisor Bono states that Board of Supervisors has received information from Governor Cuomo's office regarding a grant for the ARE park (Agriculture and Renewable Energy Park) to support infrastructure improvements. He also states that he attended the gas line public hearing in Hamilton with school superintendent Perry Dewey. They both spoke and will need to work on further documentation to be sent to the public service commission if the Town would like to have further access to the pipeline. Also, Judge Engle cannot keep his Berkshire Bank account open and will need to use another bank.

Assessor Stephen Harris informs the Board that he has been working on updating assessments and dealing with neglected exemption and sales issues, as the last reevaluation was done in 2005; many updates have needed to be done. He is also working on windmill assessment information as the 7 original windmills will be coming back onto the 2015 tax roll.

Councilpersons Patty Bikowsky and Greg Reuter along with Planning Board Chairman Roger Williams have met and discussed land use regulations. They will meet again and forward to Attorney Getman for further input. Resident Nancy Reis states that she feels the regulations are not strong enough and would like more restrictions included.

The board discusses what the penalty is for unlicensed dogs. Town Clerk will pull the local law and resolutions, board would also like the dog control officers input at the next regular meeting.
