Supervisor Bono states that the Codes Officer has inspected the wake boat owned by a Lake Moraine resident and the ballasts have been removed. He will re-inspect the boat when the hydraulic lifts have been removed and Attorney Getman states this is acceptable to have the boat remain usable as long as those accessories are taken out.

Supervisor Bono opened the sealed bids for the Spillway Road culvert. They are as follows:

Supervisor Bono presented the following resolution to the board for their consideration:

NYSERTA has been accepting applications for wind turbines which would allow 12 new turbines in the Town of Madison. They are currently viewing article 23. The resident who was living in the trailer park in an unsafe structure has moved out. Supervisor Bono also states that he will not be running for another term. Resident John Gaiser asks Superintendent Kirley to look at the damaged culvert pipe at the end of Love Joy Road. Greg Reuter and Patty Bikowsky will set up a meeting with the codes office and do review on the building fee schedule.

Supervisor Bono presented the following resolution to the board for their consideration:
