AGENDA: Patty Bikowsky made the motion the agenda is accepted, Greg Reuter 2nd it, all in favor, so moved.

MINUTES: Minutes from the July 8th regular meetings was read by Town Clerk, Tracy McLain. Greg Reuter made a motion the minutes are accepted as amended, Brad Dixon 2nd it, all in favor so moved.

Reports were presented and viewed by the Board.

Supervisor Bono states the board, village trustees and fire department and ambulance department are continuing conversation on using the American Recovery Funds to hire a paid fireman/paramedic. Greg Reuter makes the motion to allow Supervisor Bono to hire Bonadio to help with terms and legalities of spending the monies, Patty Bikowsky 2nd the motion, all in favor so moved. He also states the State Comptroller has contacted him as to the neglect of filing Judge Engle’s reports since April. Judge Engle will try to get these reports filed. The Board approves Town Clerk, Tracy McLain to begin to train Susan Anderson as deputy clerk. Union negotiations are still on hold at this time. The board discusses the need for noise ordinances, they will see what other towns have as regulations.

Highway Superintendent Kirley states the highway crew has been working on seasonal roads and shoulders. The board approves of Roy Kirley to order a new highway pick-up truck. Amy Coleman would like to add on the town website a calendar to include the pavilion rental. She would also like to order a new lifeguard stand that would cost approximately \$1500.

Michael Getnick would like to make known that he is not in favor of 600’ windmills that are proposed. Supervisor Bono and Councilman Greg Reuter both agree.

Greg Reuter made the motion to enter executive session at 8:15PM to discuss personnel, Brad Dixon 2nd it. At 8:25PM Patty Bikowsky made the motion to end executive session, Brad Dixon 2nd it, all in favor so moved.

Bills in the General Account in the amount of \$ 20,862.43 and bills in the Highway Account in the amount of \$ 356,575.11 for a total of \$ 377,437.54 were approved for payment with a motion made by Patty Bikowsky, 2nd by Brad Dixon.

At 8:45PM Patty Bikowsky made the motion to adjourn, Brad Dixon 2nd it, all in favor, so moved.
