Supervisor Bono states that sales tax is up by 18%, the law has passed to allow youths at 12 year of age to now hunt deer, he is still waiting to hear what the American Rescue Plan money may be used for. He also informs the board that by the first of the year the town would need to opt out of allowing cannabis sales in the township, however once that is done it may not be reversed and could be a loss of sales tax revenue. Both audits have been completed for the judges by Bryn on the Books. Wendy Kingsland announces there will be a public meeting in July on the windmill proposed project that is being processed through the state.
