Supervisor Bono states that the permits are in place for the Spillway Road project and they will be starting the end of October. One sealed bid was received for the Abbert Road repairs from Kitchen Excavating in the amount of \$194,700. Patty Bikowsky made the motion to accept the bid contingent on approval from Madison County Soil and Water, Greg Reuter 2nd it, all in favor so moved. The big antique field is planning on holding 2 ATV races a year, installing approximately 20 RV pads and holding the August antique show in 2021.

Wendy Kingsland, from Rolling Upland Windfarms, presented information on the upcoming windmills that have been presented to New York State. They will host a question/answer virtual meeting on September 30th at 6:00PM on this. She also stated that the original Stone Windfarm has been a working windfarm for the last 20 years.

Resident Ron Blackmore states that he has contacted the DEC on the woodchip trail proposed by Madison School and it would be okay to build. He also asked if there is a location available for a community center.

20-25 to authorize the Supervisor Bono to sign the Marcy Excavation contract.. Greg Reuter made the motion to adopt the resolution, Patty Bikowsky 2nd it, roll call vote, 4 votes yes.

20-26 to appoint Rochelle Harris as assessor and Steve Harris as his clerk. Brad Dixon made the motion to adopt the resolution, Greg Reuter 2nd it, roll call vote, 4 votes yes.

20-27 to authorize Highway Superintendent Kirley and Supervisor Bono to sign the sand and salt agreement with Madison County. Patty Bikowsky made the motion to adopt the resolution, Brad Dixon 2nd it, roll call vote, 4 votes yes.

Bills in the General Account in the amount of \$ 14,205.34 and bills in the Highway Account in the amount of \$ 59,202.10 for a total of \$ 73,407.44 were audited and approved for payment by resolution
