Supervisor Bono states that the North Court Street Bridge in Oneida was awarded the grant from the state to be replaced. The county is sharing services with Onondaga County and the position for the Director of Real Property has now been filled. A new position at the County has been created and filled and is called the Director of Emergency Services. The Board was also received correspondence from the Village of Hamilton on Community Development, a breakfast meeting with Chittenango Landing Canal Boat Museum for attracting tourists, a NYS retirement Seminar and a thank you from the Hamilton Food Cupboard.

Oriskany Falls Fire Department has questioned the boundaries of the fire district in the Town and asks that the Board consider re-instating their contract that was in effect in the late 80’s. They feel that the Sanger Hill Road and Alabam Road should be serviced by their department. The Board will look into this with the Madison Fire Chief and the 911 emergency center as to how calls are handled.

Supervisor Bono presented the following resolutions to the board for their consideration:

15-10 to authorize Supervisor Bono to move monies in the amount of \$39,000 from the Oneida Savings Money Market into the appropriate accounts to cover March’s bills. Patty Bikowsky made the motion to adopt the resolution, Brad Dixon 2nd it, roll call vote, 3 votes yes.

15-11 to accept the letter of resignation from Judge Michael Hynes effective March 25, 2015. Brad Dixon made the motion to adopt the resolution, Patty Bikowsky 2nd it, roll call vote 3 votes yes.

15-12 to appoint Michael Hynes as judge effective March 27, 2015. Patty Bikowsky made the motion to adopt the resolution, Brad Dixon 2nd it, roll call vote 3 votes yes.

Bills in the General Account in the amount of \$ 24,594.23 and bills in the Highway Account in the amount of \$ 14,370.43 for a total of \$ 38,964.66 were audited and approved for payment with a motion made by Patty Bikowsky, 2nd by Brad Dixon, all in favor, so moved.

At 8:05PM Patty Bikowsky made the motion to adjourn, Brad Dixon 2nd it, all in favor, so moved.
